The Executive Director Sri. Kumar Naik stated that the meeting is convened with specific purpose of obtaining valuable suggestions of members of EDC and eminent Caridiologists & Cardiothroasic surgeons, regarding performance of Cardiology specialty procedures whether the hospital empanelled for Cardiology under Vajpayee Arogyashree scheme should have onsite Caridiothorasic surgical backup.

The matter was discussed at length. After detailed discussion the report given by Doctor C.N. Manjunath Director, Sri Jayadeva Institute of Cardiovascular sciences and Research Centre, Bangalore was accepted and it was decided to permit the following procedures to the hospitals which do not have onsite surgical backup.

PROCEDURES MAY BE PERMITTED TO BE DONE WITHOUT ONSITE SURGICAL BACKUP

- 1. Coronary Angiogram / Peripheral Angiogram
- 2. Single Vessel / Simple Angioplasties (Type A lesions)
- 3. Renal Angiogram / Renal Angioplasty
- 4. Pulmonary Balloon Valvuloplasty
- 5. Pacemakers
- 6. Medical Managements.

PROCEDURES NOT TO BE DONE WITHOUT ONSITE SURGICAL BACKUP

- 1. Left Main Angioplasty / Multivessel Angioplasty
- 2. Post CABG Angioplasty, CTO
- 3. PTMC (Mitral Balloon Valvuloplasty)
- 4. Device Closure (ASD, VSD, PDA etc.,)
- 5. Aortic Valvuloplasty.
