Sri. S. R. Naik mentioned about the mail received from Dr. Devadasan about completion of inspection of 9 hospitals allotted to him and the reports of which will be sent by him soon etc.

The Chairman requested all the members of the committee to expedite inspection of the hospitals.

Some of the members of the committee expressed that, some hospitals do not co-operate with the members at the time of visit to the hospitals for inspection, there is poor response from the hospital authorities etc. It was decided to give one more opportunity to the hospitals and in case there is no proper response from them it was decided to reject their applications.

5. Any other subjects with the permission of the Chair.

1. Representation received from Manipal Speciality Hospital, Bangalore for inclusion of Neuro Surgery to the list of specialities granted to the hospital:

After detailed discussions it was decided to include neurosurgery to the list of specialities granted to the hospital as the member of the committee who inspected the hospital has already recommended the speciality.

2. Representation received from Kerudi Hospital, Bagalkot.

The Kerudi Hospital Bagalkot has requested the committee to delete 1) ^{Neurosurgery} neurosurgery 2) neonatal from the list of the specialities (allotted to them by the committee) as specialists concerned to above specialities have left the hospital.

It was decided to delete the above mentioned specialities from the list of specialities allotted to the hospital.

3. A) Reconsideration of application of Shree Basavalingappa Nisty Memorial Heart Centre, Gulbarga for empanelment:

The Secretary of the Committee Sri. Panduranga Pujari requested the Committee to reconsider the application of Sri Basavalingappa Nisty Memorial Heart Center, Gulbarga for empanelment under Vajpayee Arogysree Scheme.

The application of the hospital was rejected for the following reasons by the committee.

- 1) The Hospital has only 36 beds.
- 2) Specialized surgeons are not present.
- 3) The hospital does not comply with the criteria in connection with the infrastructure available in post operative ward.
- 4) Specialized surgeons with respective field of specialization are not available.
- 5) Inadequate surgeons and trained staff.
- 6) Blood bank facilities are not available. In house tie-up arrangement is not made with other

organization.

- 7) Anesthetists are not available round the clock.
- 8) No arrangement is available about Ambulance and food services.
- 9) Hospital is not having certification of Pollution Control Board.

However, in view of the fact that, there is no hospital dealing with Heart problems in the area and in view of the limited facilities available in the hospital, it was decided to empanel the hospital for providing the procedures requested to sanction by the hospital subject to the condition that they fulfill all the above mentioned conditions and furnish an undertaking to that effect.

The committee will pay visit to the hospital for verification of the facilities provided and after satisfaction about the fulfillment of conditions the hospital will be permitted to start the procedures requested by the hospital.

3.B) Reconsideration of application of Heart Centre Gulbarga for empanelment:

The Secretary of the Committee Sri. Panduranga Pujari requested the Committee to reconsider the application of Heart Center, Gulbarga for empanelment under Vajpayee Arogyashree Scheme.

The application of the hospital was rejected for the following reasons by the committee.

- 1) The Hospital has only 15 beds.
- 2) No operation theater with requisite facility.
- 3) No Cardiothoracic surgeon.
- 4) Only one duty doctor.
- 5) Only 3 Staff Nurses.
- 6) Infrastructure in post operative ward not available.
- 7) The hospital does not have sufficient experienced specialists/ Super specialists in the identified field.
- 8) Advanced diagnostic facilities are not available.
- 9) Anesthetists not available round the clock.
- 10) No arrangement is available about Ambulance and food services.
- 11) Hospital is not having certification of Pollution Control Board.

However, in view of the fact that, there is no hospital dealing with Heart problems in the area and in view of the limited facilities available in the hospital, it was decided to empanel the hospital for providing the procedures requested to sanction by the hospital subject to the condition that they fulfill all the above mentioned conditions and furnish an undertaking to that effect.

The committee will pay visit to the hospital for verification of the facilities provided and after satisfaction about the fulfillment of conditions the hospital will be permitted to start the procedures requested by the hospital.
